# Key Points


- Turnout among younger voters, aged 18 to 34 is a key data point in forecasting the election outcome accurately.

# My how things have changed since 2016.....











## How Donald Trump Won in 2016

- ➤ He was not a politician, no record, had "never been part of the problem" in Washington.
- Image of a successful businessman, great builder of teams that got things done with experts and top people.
- ➤ His winning message was restoring jobs for working class Americans, punish countries that were taking advantage of the United States. (Fair vs. Free Trade)
- That message resonated among economically depressed areas that felt no relief from Obama Administration (Wins in WI, MI, PA, OH, IA)

### How Donald Trump Won in 2016

- ➤ Hillary Clinton had a very high unfavorable image rating, in the mid-50's.
- ➤ Millions of voters voted for third party candidates, highest percentage on record. In Colorado was 9%.
- Clinton campaign did not use traditional battleground tracking polling methods, relied on flawed voter modeling.
- ➤ African American turnout was low compared to 2012.





# Playing With Political Fire to Win Over the "Progressive" Base

- Massive government programs that can only be paid for by raising taxing taxes on the uber wealthy and middle class.
- Medicare for All, abolishing private health insurance. (Cost in trillions)
- ➤ Baby Bonds, give every child born in America \$1,000 at birth to pay for housing & college.
- Immigration, "open borders", not a criminal offense, healthcare coverage for immigrants.
- Andrew Yang, Freedom Dividend, \$1,000 a month not to work.

- ➤ Andrew Yang's freedom dividend, \$1,000 to people per month not to work.
- Aggressive climate change policies like the Green New Deal.
- ➤ Paying reparations to African Americans for slavery.
- > Abolishing the Electoral College.

President Trump and his Administration protected life by fighting back against illegal drug shipments, opioid abuse, and abortion service providers.



## There Really is No Battle.....

- ➤ In 2018 Republicans lost their majority, losing 42 seats to Democrats.
- Democratic candidates received 60.5 million votes compared to 50.8 million for Republican candidates.
- Republicans need to pick up 20 seats to win back majority.



#### The Battle for U.S. House





**Likely:** These seats are not considered competitive at this point, but have the potential to become engaged.

**Lean**: These are considered competitive races, but one party has an advantage.

**Toss-Up**: These are the most competitive; either party has a good chance of winning.

- ➤ July 16<sup>th</sup> Cook Report shifted 20 races toward Dems.
- ➤ Cited Trump's abysmal polling data since pandemic began will drag down House Republicans.
- Loss of support in suburban swing districts with large concentration of college graduates.

# Control for the Senate is Likely the Only Battleground That Will Matter

- Republican majority of 53 seats to 45 Democrat seats and 2 Independents that caucus with Dems (Bernie & Angus).
- ➤ Republicans are defending 23 seats and Democrats are defending 12 seats.
- For a majority the Democrats need to win 3 seats and the White House or 4 seats and no White House.

# Cook Political Report Dems Favored to Take U.S. Senate

- ➤ July 23<sup>rd</sup>, Cook Report projects Dems to take back Senate.
- ➤ Report cites fundraising momentum for Democratic candidates, including long shots in SC, red states.
- ➤ President dismal polling numbers, poor handling of COVID, growing number of cases and death of COVID.




#### Historic Voter Turnout Among Younger Voters and African Americans




# Colorado Voter Registration by Party & Age Range




# Colorado Voter Turnout by Age Range, 2008 to 2018




#### New Mexico Voter Turnout by Age Range 2008 to 2018




#### Pennsylvania Voter Turnout by Age Range 2012 to 2018




#### Arizona Voter Turnout by Age Range 2012 to 2018






# Historical Midterm Cycle to Presidential Cycle Voter Turnout Trends

## CO Midterm to Presidential Turnout Shift Voted in 2016, Not 2014


This bar chart shows the **977,778** voters that voted in the 2016 Presidential election, but not the 2014 midterm election.

#### Forecasting the Oil and Gas Regulatory Environment Post-Election





#### Regulatory Forecast Under Biden Administration



Biden would likely pick up where Obama left off in terms of restrictive and unduly burdensome regulations on oil and gas industry through a variety of agencies within the executive branch including but not limited to the Environmental Protection Agency, Bureau of Land Management and the U.S. Fish and Wildlife Service.











#### Regulatory Forecast Under Biden Administration



- A Biden Administration would likely roll back deregulation initiatives during the Trump Administration.
- New regulations would focus on hydraulic fracking, air quality, greenhouse gas emissions, climate change, sensitive, threatened endangered species and waters of the United States.
- The regulation of air, water and wildlife will be a particular focus because the governing federal statutes reach to oil and gas activities on private lands not just federally owned lands.



## Why a Federal Ban on Fracking is Unlawful



- A ban on fracking would be an unlawful federal action by the taking of private property rights. Under the law oil and gas leases are recognized as real property.
- ➤ Under the Fifth Amendment of the U.S. Constitution, the federal government may not take a person's property without providing just compensation.





#### There are Some Limits On Presidential Power



- President does not have Constitutional or legal authority to issue a unilateral decree or direct the Secretary of Interior to ban or halt oil or gas leasing or hydraulic fracking on federal lands.
- Constitution only conveys President responsibility to ensure laws are faithfully executed, does not convey authority to legislate by unilaterally voiding or amending federal statutes promulgated by Congress that govern federal oil and gas interests. (Mineral Leasing Act/Fed. Land Policy and Management Act)





#### President Could Declare a National Emergency



- The National Emergencies Act Declaration allows the President to declare a national emergency and take certain actions in an expedited manner.
- Example is President Trump issuing Declaration of National Emergency Concerning Southern Border of US to build the border wall in 2019.
- ➤ Wild Earth Guardians have been lobbying the U.S. House for a "climate emergency" declaration and would likely pressure the Biden Administration to do the same.



#### Regulatory Forecast Federal Legislative Risks



- ➤ If Democrats have full control of Congress, there will obviously be fewer checks and balances upon the President and the executive branch.
- There is a possibility of amendment of the federal statutes governing federal minerals, and laws related to energy company taxation and deductions.
